# **Carol Caldwell Scholarship Endowment**

I would like to take this opportunity to thank all the supporters of the Carol Caldwell Scholarship Endowment for making this program a great success. We can be very proud that the supporters of the Carol Caldwell Scholarship have continued support by making their donations. I was told by the Office of Advancement Services that due to stock market fluctuations the balance in the account as of September 30, 2015 was \$147,728.36, down from \$150,923.61 as of June 30, 2015.

Spending budget for student scholarships next year will be \$4,420.00 up by \$120.00 from \$4,300.00. The yearend balance in the account has not been reflected so far.

#### <u>MINUTES</u> NC State University Woman's Club January 19, 2016

The North Carolina State University Woman's Club met at 11:30 am on Thursday, January 21, 2016 at the University Club with 37 members and guests in attendance. President Doris Wernsman opened the meeting with announcements. She thanked the hostesses for the lovely winter decorations. The hostesses were Chris Cammarene-Wessel, Sharon Ayers, Linda Roberson, and Helen McGee. We had one guest today – Beverly Watson attended with Dora Cornwell. We also have a new member – Phoebe Kot.

There were several announcements:

- Sory Bowers, Courtesies Committee, reminded everyone to let her know when condolence or get well cards are needed.
- Sharda Sawhney gave a report on the Carol Caldwell Scholarship. In June 2015, the total in the account was \$150,923. The most recent total available is September 2015 at \$147,728. Our scholarship amount is \$4,420 and the scholarship recipient was Jessica Barton who will be attending our April meeting.
- Aileen Pressley gave the Nominating Committee Report. Representatives of her committee are Betsy Meldau and Jane Stuart. The slate of officers proposed for 2016-17 is as follows: President – Doris Wernsman, 1<sup>st</sup> Vice President (Programs) – open, 2<sup>nd</sup> Vice President (Membership) – Dora Cornwell, Secretary – Georgina Werner, Treasurer – Chris Cammarene-Wessel.

Sharon Ayers gave the invocation.

Ann Frazier introduced our speaker. Mr. Derek Smith is an Environmental Engineer with the Roadside Unit with the NC Department of Transportation. He has a Master's of Science degree from NC State. He has served as the Director of the NC Wildflower Program for 25 years.

Derek gave us a great overview of the NC Wildflower Program. NCDOT has 14 divisions in the state. Each division has a roadside department conducting program implementation and agronomics. Most of the work is completed in October and July each year. They work on roadsides, at interchanges, and at the rest areas. In the past, the right-of-way areas were only mowed. Then they implemented the NC Wildflower Program. There are many color combinations that are used and we regularly use 26 species that like full sun. The soil conditions vary throughout the state so different species like sandy soil as opposed to those plants that prefer clay soil. They also try to use drought tolerant plants. The plantings are done as meadow plantings, mass plantings, striped beds, and special designs. The breast cancer ribbon and military support ribbon designs have appeared at the large intersection of I-95 and I-40. NC native plants are also used. An example is a 5-acre plot in front of a rest area in Wilkes County that has all natural and native NC plants and you can explore the space on walking paths. It takes 7,000 one-gallon daylilies to plant one acre. There is a prison in NC that is growing 200,000 to 300,000 daylilies each year. Yellow and orange colors are used most often because they can be seen at a distance. Some areas can be double cropped with daffodils blooming in the spring and daylilies blooming later in the year. It takes 8,000 daffodil bulbs to plant one acre. Red poppies have been requested to be planted along the I-95 corridor in 2018 to celebrate the 100<sup>th</sup> anniversary of World War 1. The Roadside Unit is also now in charge of litter pickup. Please do your best not to litter. We have a huge Adopt-A-Highway Program which also helps with cleanup.
