NC State Woman's Club Historical Tidbit

"I was the first woman to receive a graduate degree in the Department of Textiles. That was 1932. At that time the department was in old Tompkins Hall--built in replica of a textile factory. My thesis subject required tensile strength tests on various fibres; I shall never forget the problems involved due to fluctuating temperatures and humidity in the 'constant temperature room.' Dr. Nelson, head of the department, Dr. Hart and Dr. Hilton were very dubious about accepting a female, but were finally won over by Dr. Grimshaw and all went smoothly. At that time there was no area provided for women students to rest or lounge nor were there any dormitory accommodations. I was a member of a committee sponsored by the NC State College Woman's Club to transform one room in the basement of Peele Hall for a women's lounge--entrance in the rear!"
