There are three reasons for this: (1) ink for my printer has gone up to \$96 per cartridge and the colors are not in separate cartridges so when I empty the red, the blue and yellow are left with ink in them; (2) the computer program is set up to print six nametags at a time so cardstock and ink are wasted when there is only one guest tag to be printed; and (3) printing guest nametags each month takes extra time.
